Mayor Ward said you may have noticed our flag is flying at half-staff this evening, today is Peace Officer's Memorial Day in conjunction with National Police Week. This evening Chief Porrello is participating in the annual Candlelight Vigil this evening honoring the 188 fallen law enforcement officers from the Greater Cleveland area. One of the names being read is that of Lyndhurst Police Sergeant Mike Muzychenko who, in 1997, suffered a fatal heart attack while assisting officers in the jail with a disorderly intoxicated prisoner.
