

**ORDINANCE NO: 2017-01**  
**INTRODUCED BY: ADMINISTRATION**

**AN ORDINANCE AMENDING SECTION 961.01 OF  
THE CODIFIED ORDINANCES TITLED “CITY JAIL”  
AND DECLARING AN EMERGENCY**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY  
OF LYNDHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** Section 961.01 of the Codified Ordinances titled “City Jail” is hereby amended to read as follows (new material appears like THIS and deleted material appears like this):

**961.01 PRISONER’S MEAL ALLOWANCE.**

The Chief of Police, or any member of the Police Department who may be performing the duties of jailer, is hereby authorized and directed to expend a sum not to exceed ~~Seventeen~~ TWENTY-FIVE Dollars (~~\$17.00~~) (\$25.00) per day for each prisoner held in the City Jail during such day, or a lesser amount for a part of such day as determined necessary by the Chief of Police or his or her nominee to provide nourishment for such prisoner.

**SECTION 2.** All provisions of Section 961.01 of the Codified Ordinances of the City inconsistent herewith are hereby repealed, and all other provisions of Section 961.01 shall remain in full force and effect.

**SECTION 3.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of the City of Lyndhurst for the reason that it is necessary to implement the provisions of this Ordinance without delay in order to continue the normal operation of the City’s Department of Police. Therefore, this Ordinance shall take effect immediately upon the affirmative vote of not less than five (5) members elected to Council and signature by the Mayor or otherwise the earliest time allowed by law.

**AN ORDINANCE AUTHORIZING CHANGE ORDER NO. 1  
WITH UNITED SURVEY, INC. FOR THE 2015 SEWER  
REHABILITATION PROGRAM, AUTHORIZING THE  
CLOSEOUT OF SAID CONTRACT, AND DECLARING AN  
EMERGENCY**

**WHEREAS**, the City has previously entered into a Contract with United Survey, Inc., for the 2015 Sewer Rehabilitation Program; and

**WHEREAS**, United Survey, Inc. has successfully completed the Contract; and

**WHEREAS**, it is necessary to enter into a Change Order as set forth herein due to needed additions to the Contract or unforeseen circumstances associated with the contract in order to initiate and complete the close out procedure. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST,  
CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor be and he is hereby authorized to enter into a Change Order Contract with United Survey, Inc. for the credit amount of Sixty-Nine Thousand Three Hundred Seventy-Nine Dollars and 30/100 (\$69,379.30), in addition to the Contract heretofore authorized by the Board of Control of this Council, as and for final reconciliation of Contract quantities of said Contract, all as more fully set forth in Change Order No. 1 dated December 2, 2016, which is fully incorporated herein. The City Engineer has approved the aforesaid Change Order.

**SECTION 2.** The Director of Finance be and is hereby authorized and directed to credit the amount provided for in Section 1 of this Ordinance upon passage hereof and execution of the Change Order authorized herein and completion of the work.

**SECTION 3.** This Council determines that the work included in the Contract with United Survey, Inc. has been completed, and the Contract may be closed out, and the retainage released, pursuant to the application and certificate for final payment, the final Contract price, including additions and deletions, being One Hundred Ninety-Eight Thousand Eight Hundred Eighty-Five Dollars and 70/100 (\$198,885.70). This final payment amount has been approved by the City Engineer.

**SECTION 4.** The Mayor be and he is hereby authorized to execute all documents necessary to complete the closeout of this Contract in accordance with this Ordinance.

**SECTION 5.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 6.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City of Lyndhurst and its residents for the reason that it is necessary to approve the aforesaid changes so as to not unnecessarily delay the completion of the aforesaid Project. Therefore, this Ordinance shall take effect immediately upon the affirmative vote of not less than five (5) members elected to Council, and signature by the Mayor, or otherwise at the earliest time allowed by law.
