**AN ORDINANCE AUTHORIZING CHANGE ORDER NO. 1  
WITH DRS ENTERPRISES, INC. FOR THE 2018

**WHEREAS**, the City has previously entered into a Contract with DRS Enterprises, Inc. for the 2018 Sidewalk Repair Program; and

**WHEREAS**, DRS Enterprises, Inc. has successfully completed the Sidewalk Repair Program; and

**WHEREAS**, it is necessary to enter into a Change Order as set forth herein in order to initiate and complete the closeout procedure. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNTHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor be and he is hereby authorized to enter into a Change Order Contract with DRS Enterprises, Inc. for the credit amount of Thirteen Thousand One Hundred Ninety-Seven Dollars and 93/100 (\$13,197.93), in addition to the Contract heretofore authorized by the Board of Control of this Council, as and for final reconciliation of contract quantities for said Contract, all as more fully set forth in Change Order No. 1, dated May 28, 2019, which is fully incorporated herein. The City Engineer has approved the aforesaid Change Order.

**SECTION 2.** The Director of Finance be and is hereby authorized and directed to credit the amount provided for in Section 1 of this Ordinance upon passage hereof and execution of the Change Order authorized herein and completion of the work.

**SECTION 3.** This Council determines that the work included in the Contract with DRS Enterprises, Inc. has been completed, and the Contract may be closed out, and the retainage released, pursuant to the application and certificate for final payment, the final Contract price, including additions and deletions, being One Hundred Ninety-Four Thousand Five Hundred Eleven Dollars and 57/100 (\$194,511.57). This final payment amount has been approved by the City Engineer.

**SECTION 4.** The Mayor be and he is hereby authorized to execute all documents necessary to complete the closeout of this Contract in accordance with this Ordinance.

**SECTION 5.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 6.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City of Lyndhurst and its residents for the reason that it is necessary to approve the aforesaid changes so as to not unnecessarily delay the completion of the aforesaid Project. WITH CATTS CONSTRUCTION, INC., FOR THE 2018  
SEWER REPAIR PROGRAM, AND DECLARING AN  
EMERGENCY**

**WHEREAS**, the City has previously entered into a Contract with CATTS Construction, Inc., for the 2018 Sewer Repair Program; and

**WHEREAS**, it is necessary to enter into a Change Order as set forth herein due to needed additions to the Contract or unforeseen circumstances associated with the contract. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST,  
CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor be and he is hereby authorized to enter into a Change Order Contract with CATTS Construction, Inc., for the amount of One Thousand Six Hundred Forty-Seven Dollars and 63/100 (\$1,647.63), in addition to the Contract heretofore authorized by the Board of Control of this Council, to repair a leaky water service curb box, and to demolish a concrete collar, work not included in the original Contract, all as more fully set forth in Change Order No. 1 dated January 16, 2019, which is fully incorporated herein. The City Engineer has approved the aforesaid Change Order.

**SECTION 2.** The Director of Finance be and is hereby authorized and directed to pay the amount provided for in Section 1 of this Ordinance upon passage hereof and execution of the Change Order authorized herein and completion of the work.

**WHEREAS**, the City has previously entered into a Contract with CATTS Construction, Inc., for the 2018 Sewer Repair Program; and

**WHEREAS**, CATTS Construction, Inc., has successfully completed the Contract; and

**WHEREAS**, it is necessary to enter into a Change Order as set forth herein in order to initiate and complete the close out procedure. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor be and he is hereby authorized to enter into a Change Order Contract with CATTS Construction, Inc., for the credit amount of Twelve Thousand Seven Hundred Seventy-Two Dollars and 13/100 (\$12,772.13), in addition to the Contract heretofore authorized by the Board of Control of this Council, as and for final reconciliation of Contract quantities of said Contract, all as more fully set forth in Change Order No. 2 dated May 24, 2019, which is fully incorporated herein. The City Engineer has approved the aforesaid Change Order.

**SECTION 2.** The Director of Finance be and is hereby authorized and directed to credit the amount provided for in Section 1 of this Ordinance upon passage hereof and execution of the Change Order authorized herein and completion of the work.

**SECTION 3.** This Council determines that the work included in the Contract with CATTS Construction, Inc., has been completed, and the Contract may be closed out, and the retainage released, pursuant to the application and certificate for final payment, the final Contract price, including additions and deletions, being One Hundred Eleven Thousand Four Hundred Seventy Dollars and 50/100 (\$111,470.50). This final payment amount has been approved by the City Engineer.

**SECTION 4.** The Mayor be and he is hereby authorized to execute all documents necessary to complete the closeout of this Contract in accordance with this Ordinance.
