### **Proposed Resolution No. 2016-01**

**Approve a resolution amending Rule III, Section 1 of the Rules of the Civil Service Commission as they appear in Chapter 171 of the Codified Ordinances of the City of Lyndhurst.**

Mr. Schmidlin read the revisions to proposed Resolution 2016-01 as prepared by the Law Director.

At this point, Chief Carroll joined the meeting via cell phone and was put on speaker.

After discussion, Section 1, second paragraph will read:

In addition to the aforesaid, an applicant for appointment to the Fire Department of the City must possess a current State of Ohio certification as a paramedic, and current FF1 and FF2 State of Ohio Fire Training certificate as a State Certified Professional Firefighter, and provide evidence of the applicant's certification prior to the Commission's certification from the eligible list.

It was moved by Mr. Schmidlin, seconded by Ms. Sweeney that proposed Resolution 2016-01 be adopted as revised.

The question was put to a voice vote and passed unanimously.

### **Proposed Resolution 2016-02**

**Approve a resolution amending Rule IV, Section 6, of the Rules of the Civil Service Commission as they appear in Chapter 171 of the Codified Ordinances of the City of Lyndhurst.**
