

ORDINANCE NO. 2015-54

**AN ORDINANCE DETERMINING TO RESCHEDULE THE FIRST
REGULAR MEETING OF COUNCIL IN AUGUST, 2015 FROM
8:00 P.M. TO 7:00 P.M., AND DECLARING AN EMERGENCY**

WHEREAS, Section 121.01 of the Codified Ordinances of the City of Lyndhurst provides that regular meetings of Council shall be held on the first and third Monday of each month at 8:00 p.m.; and

WHEREAS, Council has determined to reschedule the first meeting in August, 2015 from 8:00 p.m. to 7:00 p.m. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST,
COUNTY OF CUYAHOGA, STATE OF OHIO, THAT:**

SECTION 1. The regular meeting of Lyndhurst City Council scheduled for Monday, August 3, 2015 at 8:00 p.m. shall be rescheduled to 7:00 p.m. on that date in the Council Chambers.

SECTION 2. Adoption of this Ordinance shall not serve to amend any provision of either the Charter of the City of Lyndhurst or the Codified Ordinances of the City of Lyndhurst, except to the extent as stated above.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City of Lyndhurst and its residents for the reason that the date and time must be published in advance of the meeting. Therefore, this Ordinance shall take effect immediately upon the affirmative vote of not less than five (5) members elected to Council, and signature by the Mayor, or otherwise at the earliest time allowed by law.
