

**ORDINANCE NO. 2018-23  
INTRODUCED BY: ADMINISTRATION**

**AN ORDINANCE AUTHORIZING THE MAYOR TO CONTINUE THE AGREEMENT WITH A COUNCIL OF GOVERNMENTS COMPOSED OF THE CITIES OF SOUTH EUCLID, HIGHLAND HEIGHTS, LYN DHURST AND MAYFIELD HEIGHTS, AND THE VILLAGE OF MAYFIELD, PROVIDING FOR THE CONTINUATION OF THE COMMUNITY PARTNERSHIP ON AGING, AND DECLARING AN EMERGENCY**

**WHEREAS**, IN 2013 the Cities of South Euclid, Lyndhurst, Highland Heights, Mayfield Heights and the Village of Mayfield entered into a Council of Governments Agreement continuing the Community Partnership on Aging (CPA); and

**WHEREAS**, it is the desire of this Council to continue said Agreement in accordance with its terms. Now, therefore,

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYN DHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** This Council determines to continue the Council of Governments Agreement with the Cities of South Euclid, Highland Heights and Mayfield Heights and the Village of Mayfield until said Agreement is either modified or terminated by a party in accordance with its terms.

**SECTION 2.** The City of Lyndhurst is hereby authorized to pay into the CPA its proportionate share on a per capita basis, as calculated pursuant to the Agreement, but in no respect shall such proportionate share exceed One Hundred Fifty Five Thousand Dollars (\$155,000.00) annually without further action by this Council.

**SECTION 3.** The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City of Lyndhurst and its residents because it is necessary to maintain the Community Partnership on Aging without interruption and shall therefore take effect immediately upon passage of the affirmative vote of not less than five (5) members of this Council or the Mayor or otherwise at the earliest time allowed by law.
