

**ORDINANCE NO. 2019-13**  
**INTRODUCED BY: ADMINISTRATION**

**AN ORDINANCE AMENDING SECTION 1309.01 OF THE CODIFIED ORDINANCES OF THE CITY OF LYNDHURST, OHIO PERTAINING TO THE PLUMBING CODE OF OHIO, REPEALING ALL ORDINANCES INCONSISTENT HEREWITH, AND DECLARING AN EMERGENCY**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:**

**SECTION 1.** Chapter 1309.01 of the Codified Ordinances of the City of Lyndhurst, Ohio titled "2011 EDITION OHIO PLUMBING CODE" is hereby amended to read as follows:

**1309.01 ~~2011 EDITION~~ OHIO PLUMBING CODE ADOPTED.**

Pursuant to Ohio R.C. 731.231 there is hereby adopted by and for the City for the construction, alteration, movement, enlargement, replacement, repair, equipment, use and occupancy, location, maintenance, removal and demolition of every building or structure or any appurtenances connected or attached to such buildings or structures, and for other purposes, that certain Code known as the Ohio Plumbing Code, ~~being particularly the 2011~~ **CURRENT** edition thereof, recommended by the Ohio Board of Building Standards, save and except such portions as are hereinafter modified or deleted, including all updates and appendices. In addition, all previous Editions shall remain in full force and effect unless subsequently modified.

**SECTION 2.** Existing Section 1309.01 of the Codified Ordinances of the City of Lyndhurst is hereby repealed.

**SECTION 3.** This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of the City of Lyndhurst for the reason that it is necessary to institute the aforesaid change to the Codified Ordinances to be effective as soon as possible. Therefore this Ordinance shall take effect immediately upon the affirmative vote of not less than five members elected to Council, and signature by the Mayor, or otherwise at the earliest time allowed by law.
